TO ANY PEACE OFFICER OF THE STATE OF TEXAS AND THE TAX COLLECTOR(S) OF THE HEREINAFTER NAMED TAXING UNIT(S), GREETINGS:

WHEREAS on the 3RD day of November, 2021, A. D., in the 84TH District Court of Hutchinson County, Texas, in Cause No.44934, styled *Hutchinson County vs. Little Pringle Wind 1 Olympia, LLC, Little Pringle Wind 2 Olympia, LLC, Olympia Renewable Platform, LLC* and specifically regarding the Defendants, Little Pringle Wind 1 Olympia, LLC, Little Pringle Wind 2 Olympia, LLC, Olympia Renewable Platform, LLC, hereinafter collectively referred to as Taxpayer, the following named taxing unit(s), to wit: Hansford County Tax Office and Hutchinson County Tax Office made application for a Tax Warrant authorizing the seizure and sale of the personal property of the taxpayer as provided by Subchapter B of Section 33 of the Texas State Property Tax Code.

The respective amount of taxes, penalties, interest and attorney fees, due each of the taxing unit(s) and the name and address of the taxpayer is set out in the attached statement which is a true and correct copy of the entries on the delinquent tax roll(s) of the above-named taxing units and which statement is incorporated by reference into this warrant.

NOW THEREFORE, YOU ARE COMMANDED TO seize, levy upon and advertise for sale as under execution so much of the personal property of the taxpayer as is reasonable necessary to satisfy the taxes, penalties, interest, and attorney fees of the aforementioned taxing unit(s), and all costs of seizure and sale.

The taxpayer named herein or any other person in possession and control of the personal property is found is hereby directed to disclose to the officer executing this warrant, the name and address, if known, of any and all persons having an interest in the property seized. Said taxpayer or other person having possession of the personal property of the taxpayer against whom this warrant is issued shall surrender said property pending its sale.

The tax collector(s) shall make a reasonable inquiry to determine the identity and address of any person having an interest in the property and shall deliver a written notice stating the time and place of the sale and briefly describing the property seized.

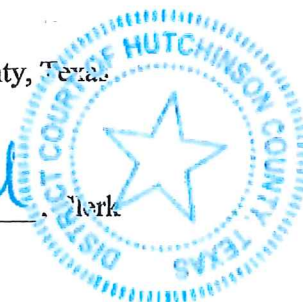
The officer and the tax collector(s) executing this warrant shall make proper conveyance to the purchaser(s) of said personal property, upon purchaser(s)' compliance with the terms of said sale within the time and manner provided by law, and shall execute and return this warrant according to its terms and the requirements of law.

HEREIN FAIL NOT, under penalty of law, and due return make of this warrant within 90 days from date hereof, with your endorsement thereon, showing how you have executed the same.

ORDER FOR TAX WARRANT

On November 3, 2021 a Joint Application for Tax Warrant was presented to the Court as authorized and provided for in Subsection C Section 33.22 of the Taxes State Property Tax Code, and the Court being of the opinion that a Tax Warrant should be issued.

IT IS THEREFORE ORDERED that the Clerk of this Court issue a Tax Warrant directing a peace officer in the county and the tax collector to seize, levy upon and sell so much of the personal property of Little Pringle Wind 1 Olympia, LLC, Little Pringle Wind 2 Olympia, LLC, Olympia Renewable Platform, LLC, as is reasonably necessary to satisfy the taxes, penalties and interest and attorney fees of the Taxing Units named in the Application and attached statements and all costs of seizure and sale.

IT IS FURTHER ORDERED that the Tax Warrant direct the person whose property is seized to disclose to the officer executing the warrant the name and address, if known, of any other person having an interest in the property.
